



Healthy Places Walkability Study Clinton Estates Neighborhood Pride

Columbus Public Health Healthy Places program is conducting walkability studies in the 2009 Neighborhood Pride areas. The goals of the walkability study are to increase neighborhood residents walking in their neighborhood and to identify destination places that are within walking distance. This will be done by walking with neighborhood residents to 1) identify positive places to walk in their neighborhood; 2) inventory barriers to pedestrians and bikers; and 3) identify neighborhood destinations.

The Clinton Estates neighborhood is very safe and residents really like their neighborhood. They want to keep their neighborhood as a nice, safe place to live and encourage neighbors who have unmaintained properties to improve and be part of the neighborhood as well.

Neighborhood Findings

Neighborhood

• My interest is to make the neighborhood nice as possible for my kids to grow up.

Street

- Morse Road is too busy, I would not cross.
- Stop sign is needed at Danforth Rd and Shanley Dr., people have gone as fast as 60 m.p.h. on Shanley Dr. because nothing slows them down right now.
- Sidewalks have "toe trippers" where the sidewalk is raised up at the joint. People would love to replace their sidewalks but the cost is high.
 - o Trips little kids, hard for them to ride their bikes, hard to push a stroller.
 - We take bike rides with the kids in the trailer instead of walking on sidewalks because of the condition.
- New sidewalks were put in on Maize Rd.

Safety

- This neighborhood is very safe except for traffic.
- Karl and Morse Roads there are robberies early in the morning mostly associated with bars letting out and people coming back to the apartments.
- Police Division has done our statistics and within the neighborhood we do not have any crime, we are the safest area in Columbus.

<u>Utilities</u>

- Most storm water sewers in the neighborhood have wide openings that children can fall through.
- We try to get people to clean out the street gutters and sewers themselves.
- Sewers are blocked with trash from kids walking to and from school, in the winter ice blocks the sewers.

Housing

- Several neighbors are complaining about rats in their yard.
 - o On South Carbone near Frisbee
 - o Near the entrance to Brookhaven at Carbone and Frisbee
 - 1223 Carbone has seen rats in her yard and thinks they could be from the neighbor's house at 1231 Carbone.

Questions

Several neighborhoods complain of rat problems, they all seem to be near the school, who should we call? Rat complaints are a code enforcement issue and should be called into the 311 system. (311 or 645-3111). Columbus Public Health does not deal with rat complaints.

If a neighbor has a pond of standing water, who can we report it to? The issue should be reported to 645-3111.



Most of the stormwater sewers in the neighborhood have wide openings. Neighbors witness kids throwing trash in them and they worry about little kids being able to fall into the sewer.


