Healthy Places Walkability Study Tussing Neighborhood Pride

Columbus Public Health Healthy Places program is conducting walkability studies in the 2009 Neighborhood Pride areas. The goals of the walkability study are to increase neighborhood residents walking in their neighborhood and to identify destination places that are within walking distance. This will be done by walking with neighborhood residents to 1) identify positive places to walk in their neighborhood; 2) inventory barriers to pedestrians and cyclists; and 3) identify neighborhood destinations.

The Tussing neighborhood is most concerned about safety in their neighborhood. The neighborhood has a park, sidewalks, great street trees and good residents. However, neighbors do not feel safe walking alone or using their park because of teenagers and young adults that roam the neighborhood and take over the park. Speeding on streets is also an issue.

Neighborhood Findings

Recreation

- Neighbors are really interested in encouraging families to use Independence Park not only for a community space but it would keep out the bad element.
- There is a walking path in the park.

Walking

- We have lots of walkers in our neighborhood, in the evening and the morning and families with babies.
- Most neighbors would not feel safe walking alone in their neighborhood, especially at night and in the park.
- My comfort level of walking depends on the crowd I see in the park.
- I walk everywhere, even up to 10p at night.
- If I have to walk alone when it is dark, I keep within a few blocks of my house.
- Stray dogs and dogs off leash worry me and have bothered me and my dog. I carry a stick.

BOARD of HEALTH

Cars do not slow down for pedestrians.

<u>Safety</u>

- Gemstar is a street we avoid.
- Teenagers and young adults roam the neighborhood and night and hang out in the park.
- We have an issue with gang houses in our neighborhood.
- Publicize the curfew even if we do not have special officers assigned to enforce it.

Traffic Concerns

- There are no traffic signs at many intersections throughout the neighborhood (i.e. stop signs)
- Specific intersections with no signage of note are:
 - o Deepwood and Bennell
 - o Continental and Centennial
 - o Metuchin and Arrowsmith
- Streets that are cut-through streets and have high speeds are:
 - o Centennial Dr
 - o Bennell Dr
 - o Ambarwent Rd
 - o Arrowsmith Dr
- Residents would like to have speed bumps on the above streets

<u>Infrastructure</u>

- Water pipes in the sidewalk with no caps were noted at::
 - o In front of 6832 Metuchen Place
 - o 2991 Arrowsmith Drive
 - o 6825 Arrowsmith Drive
 - o 3095 Deepwood Drive
 - o 6764 Bennell Drive (water pipe in grass near driveway and sidewalk)
- Sidewalks are a problem throughout the neighborhood-either they are flaking and full of gravel or they are pushed up and are tripping hazards.
- The property owned by the Groveport Madison school district is an empty field and does not have sidewalks. There is also a sidewalk gap on Centennial between Deepwood Dr and Hubbardton Pl and on Arrowsmith between Creighton Pl and Stockton Ln where the park meets the road.
- The city built an ADA ramp in front of my house and I have had flooding and drainage ever since. The water backs into my garage and I now have foundation problems.



Independence Park has lots of green space, basketball courts and a walking path. Neighbors would like to see more families in the park and less bad people.

Flaking sidewalk is common in the neighborhood as is sidewalks that are raised or uneven.

This report will be used to create walking maps through the neighborhood. The mile-marked maps will highlight neighborhood features, safe paths and destinations. The report will also be forwarded to City of Columbus departments that can assist neighborhoods in addressing their needs.

Questions from the neighborhood

Will there be mosquito fogging in our neighborhood this year?

Mosquito traps will be set starting the week of 6/1/09 and fogging will occur in late June/early July. This website:

Why are there no stop signs or yield signs at our intersections?

The traffic volume does not "warrant" or allow for stop or yield signs. Drivers are supposed to use basic rules of the road and yield to the person on the right.

If someone falls on your sidewalk are you liable? What about in the winter? Still getting confirmation on this question.

How far is the walking path in the park?

The path is .36 miles (3 times around is 1.08 miles). Recreation and Parks reports .2 mile on their website but they confirmed the .36 miles and will be updating the website.
