- The Board was advised that the draft updates for Rules and Regulations for Mobile Food Vending and Public Right of Way Drafts will be combined for the next meeting.
- The Board was advised that the Draft of Mobile Food Vending Board Bi-Laws with the Department change will be discussed at the next meeting.
- The Board was advised that the License Section's move to the Department of Building and Zoning was completed on April 01, 2024.
- The Board was advised that regarding the request for additional PROW cart locations in the university area that the License Section and Public Service employees walked the area to locate additional locations. The four (4) locations suggested were:
