07/18/2024

- The meeting was called to order by Chairperson Cathy Collins at 2:08 pm.
- The roll call of Board Members showed eight (8) members present, five (5) members absent and one (1) currently vacant representative.
- A motion to dispense of the reading of the January 18, 2024 & April 18, 2024 Board Meeting Minutes, motion seconded and carried.

Old Business

- All present Board Members present have completed the Pledge of Ethical Conduct and Oath of Office.
- The Board was updated on the Draft of Mobile Food Vending Board Bi-Laws with the Department, but no vote taken until next meeting.
- The Board was updated on that the draft for Rules and Regulations for Mobile Food Vending Truck/Trailer Draft. After discussing some issues with the draft, Board Member Nik Stefanik made a motion to accept with changes discussed. Board Member Zach James seconded the motion, motion carried.
- The Board was advised that additional (4) PROW cart locations listed in the University Area that were voted on the last meeting have been added to Street Food Finder for use.

- The Board was advised on the new Pushcart Spots at Bicentennial Park are currently on hold, but they are still working on the issues involving No vending allowed in City Parks.
- The Board was advised that Building and Zoning are discussing MFV Parking Restrictions.
- The Board was advised on 2024 Mobile Food stats as on 07/15 of:
391 Mobile Food Vending Permits issued.
59 PROW issued of those 30 were Pushcarts
49 MFV Pending, incomplete paperwork or failed inspections. This could cause a change in the renewal process.
