Incident Summary: ***UPDATE January 17, 2025: The suspects in this investigation have been identified and arrested. On 2-28-2024 at 1:11am, Patrol Officers responded to an accident in the 3000 Block of E Main St, a vehicle into a building. Upon arrival, Officers located the victim, Shandar L. Weaver M/B/28, who was suffering from a gunshot injury. The victim was transported to a local area hospital in critical condition. Despite receiving life saving medical treatment the victim succumbed to his injuries and was pronounced deceased at 2:43am.

The investigation continues.
