Incident Summary: ****Update June 4, 2024: On June 4, 2024, the suspect in this homicide has been identified as Kenneth Hairston. Kenneth Hairston was charged with Involuntary Manslaughter and having Weapons While Under Disability. Kenneth Hairston was slated at the Franklin County Jail.****			
****Update June 2, 2024: The victim in this homicide has been identified as Da'Mya Cummerlander F/B/18. The next of kin notification has been completed.****			
On June 2, 2024, at 12:35am, Patrol Officers responded to a shooting in the 2600 Block of Woodsedge Rd on a shooting. Upon arrival, Officers located the victim, who was unresponsive and suffering from a gunshot wound. The victim succumbed to her injuries and was pronounced deceased at 12:44am. The victims identity will be released when next of kin notification has been completed.			
The circumstances of this incident are still under investigation by Homicide detectives. The investigation continues.
