**Incident Summary: \*\*\*Update: On June 3, 2024, detectives filed charges against Deven J. Price and Abdoulaye O. Diallo for their involvement in this incident. Detectives are actively working this case and are in the process of identifying at least two other individuals who are persons of interest. On May 13, 2024, at approximately 9:45pm, officers were dispatched to the 2700 block of Brentnell Ave on the report of a shooting. The officers arrived at the scene and found the victim suffering from an apparent gunshot wound. Mifflin Township Medic 132 arrived and pronounced the victim deceased at 9:51pm. At this time, detectives are trying to determine the circumstances regarding this incident. This is an on-going investigation.
