**Incident Summary: \*\*\*\*Update June 27, 2024:** Investigators are still attempting to obtain additional information regarding the Homicide of Danyaze "Dany" Evans-Kourouma. Ms. Evans-Kourouma was known to frequent the area of Lilley Ave., Berkeley Rd. and E. Livingston Ave. Anyone that knows "Dany", was with or saw "Dany" prior to her death, is encouraged to contact Det. J. Brandt at 614-645-4077.\*\*\*\* Please see attached flyer of victim.\*\*\*\*

\*\*\*\* Update May 10, 2024 - On May 9, 2024, the victim of this homicide was identified as Danyaze Evans-Kourouma F/B/33. Next of Kin notification has been completed. Investigators are still attempting to obtain additional information regarding this incident. \*\*\*\*

On April 25, 2024, at approximately 2:22pm, Homicide Investigators responded on a suspicious death investigation in the area of Noe-Bixby and Carbondale. A body was discovered by workers in the area. The victim, who has not been identified at this time, was pronounced deceased at 2:18pm by CFD personnel.

As a result of an autopsy that was performed on April 26, 2024, it was determined that the victim was suffering from a gunshot wound, that resulted in her death.

Investigators are still attempting to identify the victim, and determine the circumstances regarding this incident.

The investigation continues.

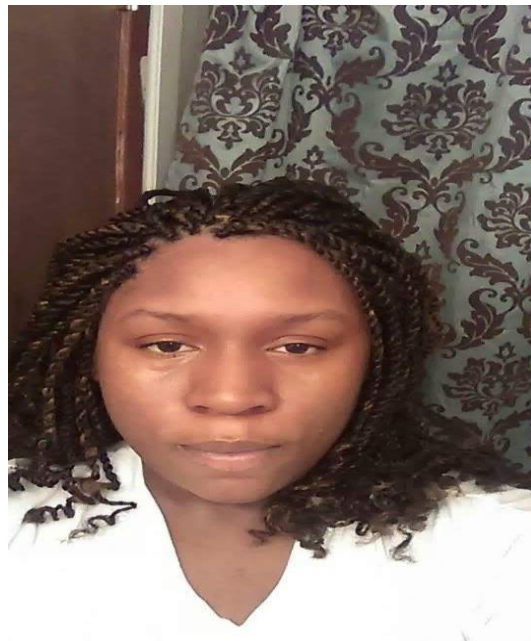

On April 25, 2024, at approximately 2:05 p.m., Columbus Police Officers were dispatched to a construction site located off of Noe-Bixby Rd., north of Carbondale Drive, near the Interstate 270 overpass. Upon arrival, Officers found the victim, Danyaze Evans-Kourouma, F/B/33, suffering from a gunshot wound. Ms. Evans-Kourouma was subsequently pronounced deceased. Ms. Evans-Kourouma was known to frequent the area of Lilley Ave., Berkeley Rd. and E. Livingston Ave. Detectives are still attempting to determine the circumstances surrounding the incident.
