Incident Summary: \*\*\*UPDATE 10/27/2024\*\*\* On October 27, 2024, a third individual was charged with one count of Murder as a result of the continued investigation into this incident. This individual remains at large and is identified as:

Mekhi G. Webster, Male, Black, 22 years old.

\*\*\*UPDATE 10/24/2024\*\*\* On October 24, 2024, Mr. Dock Parker was charged and arrested on one count of Murder as a result of the continued investigation into this incident.

\*\*\*UPDATE\*\*\* On 6/27/2024, the suspect in this incident, Mr. Jaivon Jones, was arrested without incident by CPD SWAT personnel.

\*\*\*UPDATE 4/17/2024\*\*\* The victim in this homicide has been identified as Angel Salguero Diaz. Next of kin notification has been made.

On April 14, 2024, at approximately 10:17 PM, Columbus Police Patrol officers were dispatched to the area of the 1300 block of E. Hudson Street on an unknown complaint. Officers arrived at the scene and found a victim suffering from an apparent gunshot wound. The officers rendered aid to the victim until CFD Engine 13 personnel arrived and pronounced the victim deceased at 10:24 PM. At this time, investigators are attempting to determine the circumstances that led to this incident. The victim remains unidentified at this time.
