Incident Summary:
On Friday, October 4, 2024, at 3:39PM, Columbus Police Officers were called to the 300 block of Lechner Ave. on a report of a shooting. On arrival, officers found Carnal Mixon, 17, suffering from an apparent gunshot wound. CFD Medic 817 transported Mixon to Grant Medical Center in critical condition, where he was pronounced deceased at 4:04PM.

*****UPDATE:** Detectives have charged Robert Clark III, 15, with Murder for causing Mixon's death. Clark's father, Robert Clark II, 34, witnessed Mixon's murder. Following Mixon's murder, Clark II fled with and then harbored and concealed his son. As a result, Clark II has been charged with Obstructing Justice. Clark III is currently incarcerated in the Franklin County Juvenile Detention Center. Clark II is currently incarcerated in the Franklin County Jail.

The investigation into Mixon's death is ongoing.
