Incident Summary: ***Update 9.23.2024: The suspect was apprehended in Ferdinand, Indiana by the Indiana State Police at a Sunoco service station earlier this morning. The suspect will be transported back to Ohio pending an extradition hearing.***					
On September 22, 2024, at 10:29pm, Patrol Officers were dispatched to the 1000 Block of Cliff Creek Drive on a shooting. Upon arrival, Officers located the victim, Adult #1, suffering from a gunshot wound. The victim was transported to Doctor's West Hospital in life threatening condition. Despite receiving life saving medical care, the victim succumbed to his injuries and was pronounced deceased at 11:07pm. An argument between the victim and suspect led to the shooting. The victim's name will be released upon the completion of the next of kin notification. Investigators have filed a murder warrant for the arrest of the suspect, who has been identified as Alejandro Jose Angulo-Ramos					
The investigation continues.
